- During the qualification period, if your rank is higher than the base rank, that rank will be the new base rank for following months *Points from maintaining new rank will be given once a new rank is maintained during the qualification period.
- Any Base rank below Senior Director Rank, participants have to achieve new rank and maintain the new rank for 1 month during qualification period. For Director Ranks and above, BAs must maintain at least 1500 TV in order to accumulate points for that particular month. For Director Rank and above, BAs must maintain at least 1500 TV in order to accumulate points for that particular month.
